She also reported that all siding out requests to Cheshire East had been stalled for quite some time, but after a change of personnel such requests should start to be processed, including ours for a stretch of the A34.

090/25 - Update on Councillor Vacancies

The Clerk reported that the vacancies had been advertised and the deadline for parishioners to call for an election is 22nd July. If no such election is called then the Council may co-opt someone onto the Council.

091/25 - Highways

The Clerk noted that he is chasing Cheshire East Highways about the installation of posts for the new SID. Cllr Wardlaw said that the terrible stretch of road on the A34, by the entrance to Bent Lane, would be dressed in this Financial Year. Some residents at the Village Green had expressed concern at the speed of vehicles going through the pinch-point, but the Council felt there was very little that could be done to change driver behaviour.

The Clerk will chase Streetscape about their spraying efforts and seek a site visit with them to discuss our plans for wildlife etc.

The Chair noted that she had asked Crewe Colour Printers to print a limited number of the new Neighbourhood Plan documents as reference works for Councillors.
